Describe the Event: A single, local-themed, light-filled mini-golf green. Free to play. The community will be provided with putters and balls, and can play for as long as they wish from February 2nd, 2026, until May 1st, 2026. Security A large base side will make tipping very unlikely. If needed, can add anchors to the asphalt/concrete. Materials $\frac{3}{4}$ " inch thick nautical grade plywood, PVC pipe and trim boards, plastic turf, and enamel paint. Maintenance CultureHouse will clean, remove snow, and replace putters and balls.

Describe any Entertainment at the Event (if none, type None): Miniature Golf

Describe any tents, inflatables, or other temporary structures to be used (if none, type None): A miniature golf green with a miniature triple-decker as the green. Gameplay Hit the ball up the first ramp and into the 2nd or 3rd floor porches, or around the ramp and through the first floor door. Watch out! There is a hole behind the ramp that will send your ball down a tunnel to the lower green if your ball goes in, and you will have to hit it up the second ramp and start over:(If your ball makes it onto a porch or through the door, it will roll down a tube to the final green.
