

Re: Amend 360 Medford Street Zoning Map to High-Rise District

To the City Council:

I am the owner and have been the owner of 360 Medford Street (Mobil Station) since 1978. With the GLX completion in sight, the time is near for a new look.

The Subject Property is a corner lot at the base of a hill abutting two wide streets, City owned parcel (now parking lot), and MBTA tracks in the rear. There would not be obstruction of any kind making this site and the City abutting property ripe for high-rise development such as but not limited to the Cambridge Innovation Centers for startup companies and artists. It is important to Gilman Sq. development to seek out ideas and a map change to high-rise district is a positive step.

On October 1, the Planning Board approved a zoning map change to MR6 for 91 Marshall St.

255 Pearl St.

345 Medford St.

but omitted 360 Medford St.from the 15 registered voters petition maintaining the current MR4 zone.

The reason could only be that 360 Medford St. should be in the high -rise district.

I respectfully request that the City Council approve this Zoning Map Amendment for 360 Medford St. to high-rise district as soon as possible.
