1. **Approval of the September 14, 2016 Minutes**
2. **200140: Discuss** (Connolly, Sullivan, Rossetti, White Jr.) – That the Chief of Police, the Chief Fire Engineer and the Director of Traffic and Parking consider a "Don't Block the Box" program at key intersections that impede the flow of traffic and present a public safety hazard, and report back to this Board in writing within 30 days.
