The meeting took place in the Committee Room and was called to order at 6:04 PM by Alderman Connolly and adjourned at 7:14 PM.

Mr. Snyder discussed intersections that presently have the signage and said that a study would be conducted on other intersections. Lt. Polito spoke about Union Square and enforcement. Pavement marking areas, various locations and evaluation time and methods were discussed. Chairman Connolly noted that similar signage is used in mid-town Manhattan and he asked that a memo regarding a plan of action be provided prior to the next meeting of the committee. He also suggested posting the fine on the signage. Alderman McLaughlin would like to move forward on this quickly and as inexpensively as possible. He voiced his objection to the look of the signage exemplar provided.

Mr. Rawson discussed the ways the Bicycle Committee would like to increase safety. He also spoke about education, the “dutch reach” method, street markings, additional bike lanes, on street parking, hot spots, crash data, directed patrols, fines and contractor notifications. Alderman Davis spoke of his concern of having bike lanes next to car doors. He also suggested that bike safety information be provided during the parking permit process. Alderman Davis said that bicycles are vehicles and have the same rights as automobiles, adding that bike safety should be made part of driver education. Alderman McLaughlin would like to see educational videos and more bike lanes, noting that there are no bike lanes on Somerville Avenue, but there are bicycle accidents.
