I recently learned that Somerville is seeking applicants to fill a vacancy for a *full member* position on the Planning Board. I am currently serving as an Alternate Member on the Planning Board, and I wish to apply for the full member position.

In the short time I've served on the Planning Board, I hope I've shown my ability to critically engage and provide feedback that helps make projects better. I'm honored to have a voice on the Planning Board, and I'm deeply interested in participating in an ongoing voting capacity. I feel strongly that the Planning Board has an obligation and a responsibility to ensure that the development projects that come before it for approval are consistent with our community's values and goals as defined in SomerVision and the Somerville Zoning Ordinance. We must realize our goals for increased housing, affordable housing, commercial development, open space, and equity.

I have been a resident of Somerville since 2009 and have been a community advocate on planning and zoning issues, particularly with respect to transformation areas including Union Square, Boynton Yards, and Assembly Square. In May 2020, I was honored to be appointed as an Alternate Member of the Planning Board and have already been an active and engaged participant. My voice has been informed by my experience as a community advocate, including involvement in the formation of the Union Square Neighborhood Council, advocacy around Union Square zoning issues, and participation in the McGrath Boulevard Project Development Working Group. I am also is a trustee of the Cambridge Health Alliance and was previously involved in Union Square Main Streets and Union Square Neighbors.

Over the past 10 years, I have actively participated in numerous community meetings and planning workshops. When the first iteration of the Union Square zoning was proposed, it did not include any provision for family-sized (3 bedroom) affordable housing units, despite being called for in the Union Square Neighborhood Plan. We were successfully able to add this to the zoning. I also supported the Real Estate Transfer Fee Home Rule Petition as well as the redevelopment and addition of affordable housing units at Clarendon Hill. I am a strong supporter of affordable housing efforts and believe our community needs to make significant inroads to preserve housing options in Somerville for individuals and families of all income levels. Before moving to Massachusetts in 2000, I worked in a homeless shelter for families in Madison, Wisconsin where I was also as an appointee to Madison's Community Development Block Grant Commission.

I believe I am a good candidate to be a full voting member on the Planning Board because of my experience in these issues in Somerville as well as the value I place on the input, ideas, and contributions of residents in our decision-making processes, including people who don't always have an opportunity to voice their perspectives. We need to be mindful of equity and historical social power when it comes to decisions of planning. That requires listening, and I try to be active listener in all that I do. Professionally, I am a health policy consultant and work on issues centered on improving publicly funded health care for vulnerable populations. I bring this health and wellness-oriented perspective to the Planning Board.

I've always been committed to helping in my community and working on issues and efforts that seek to preserve and enhance our lives, including those who don't always have a voice in decision-making. Being a voting member of the Planning Board would enable me to continue in this work. Thank you for the opportunity to apply.
