The Massachusetts Department of Transportation, Highway Division, acting on behalf of the Department of Conservation and Recreation (formerly Metropolitan District Commission-MDC), as authorized by Chapter 25 of the Acts of 2009, does hereby alter a portion of a highway, being known as Monsignor McGrath Highway (Route 28), in the City of Somerville, County of Middlesex.

The alteration consists of revising the location line of the April 17, 1956 (Taking Plan No. 3) of Department of Conservation and Recreation Parkway of Monsignor McGrath Highway (Route 28) on the northerly side thereof and more fully described as follows:

The Main baseline used for this alteration begins at a point within the existing roadway of Monsignor McGrath Highway (Route 28), at N 2961698.8151, E 768811.3275, shown on the plan hereinafter referred to as station 0+00.00 and extends thence, S 55°44'42" E 300.00 feet to the point of ending thereof, at N 2961529.9523, E 769059.2899, shown on the plan hereinafter referred to as station 3+00.00.

The stations hereinafter referred to are points thereon. The Coordinate system used is the Massachusetts Coordinate System North American Datum of 1983 (NAD 83).

The location of highway hereby altered and laid out begins at a point on the northerly location line of April 17, 1956 (Taking Plan No. 3) of Department of Conservation and Recreation Parkway of Monsignor McGrath Highway (Route 28), at N 2961729.0471, E 768843.6558, said point bearing N 34°15'18" E and being 43.18 feet distant from station 0+09.70 of the Main baseline, hereinbefore described and extends thence, following said location line S 74°55'07" E a distance of 102.82 feet to the point of ending thereof, on the northerly location line of September 20, 2023 (Layout No.8951) of the Department of Conservation and Recreation Parkway of Monsignor McGrath Highway (Route 28), at N 2961702.2937, E 768942.9343, said point bearing N 34°15'18" E and being 76.95 feet distant from station 1+06.82 of the Main baseline, as hereinbefore described.

The land affected by this layout is registered land being Parcels 23 and 28 on Land Court Plan No. 8602B, Certificate of Title No. 286444, Registration Book 1624, Page 162.

The location line of the Department of Conservation and Recreation Parkway hereby altered and laid out as hereinbefore described is to be further defined by bounds set thereon at the points of beginning and ending, thereof, where feasible.

The location line of said highway, as hereby altered and laid out is shown on a plan signed by the Chief Engineer, and signed by the Massachusetts Department of Transportation, Highway Division and on file in its office, said plan being entitled:




