# 190999 - That this Board's Committee on Public Health and Public Safety once again address the safety of the abandoned building at 82 Pearson Avenue, which remains in disrepair.:

Mr. Proakis informed the committee that the property has been identified as a 3-family house and that it has been put up for sale by the receiver.

Mr. Champion assured the members that there was no loss of communication within the department since there are multiple alternative methods of communicating available, if needed.

Alderman Pero stated that the fence installed to block the sound was not effective. Mr. Koty will visit the site to investigate other possible options.

**192058** - That this Board requests that a representative from the Administration appear before the Public Health and Safety Committee to provide an update on the proposed Bicycle/Pedestrian Public Safety Campaign.:

Ms. Rossetti spoke about recent bicycle safety meetings, signage and discussions with CAMUSA and explained that delays have been the result of recent personnel changes in key positions. Mr. Hill, a resident of the city, spoke about the dangers of bicycling on sidewalks and he introduced a video on that subject. Lt. Donovan spoke about the problem of ticketing for bicycling violations and noted that the cost of enforcement is more than the \$20 fine. Chairman White <u>requested that</u>

*the Police Chief appear before the committee with a plan for enforcement for the spring of* <u>2012</u>. The item will remain in committee for further discussion in February.

## 192096 - That the Committee on Public Health and Safety place Albion Park and its related noise issues on the next possible agenda to discuss lighting and basketball play at all hours of the night.:

Mr. Bucca, who lives near Albion Park, addressed the committee and spoke about the problems with the lighting at the park, with the consumption of alcohol there, and with people driving to the park to play basketball in the park well after 10:00 pm. He would like to have the 10:00 PM curfew imposed and to have the park patrolled by police. Alderman O'Donovan addressed the issue of the parking lot lights abutting the park and informed the members that the owner of the property is being cooperative. Chairman White directed that the police be more active in their enforcement and inform violators that they are trespassing and could be arrested if they violate the closing hours in the future.

192100 - That this Board requests that the Administration update this Board on actions proposed and taken regarding the negative impact of activities, lighting, and noise on the quality of life in the neighborhoods abutting Conway Park and the Skating Rink.:

Residents expressed concerns about a 10:00 PM curfew at the park and about parking at the rink. Mr. Halloran spoke about a parking plan for the area and Mr. Koty stated that the lights are on automatic timers and can be adjusted, if necessary.

Chairman White's motion <u>that the Administration inform the committee when the parking plan</u> for the rink is ready, was approved.

Chairman White's motion *that the Commissioner of Public Works submit a lighting plan for the rink to the committee*, was approved.
