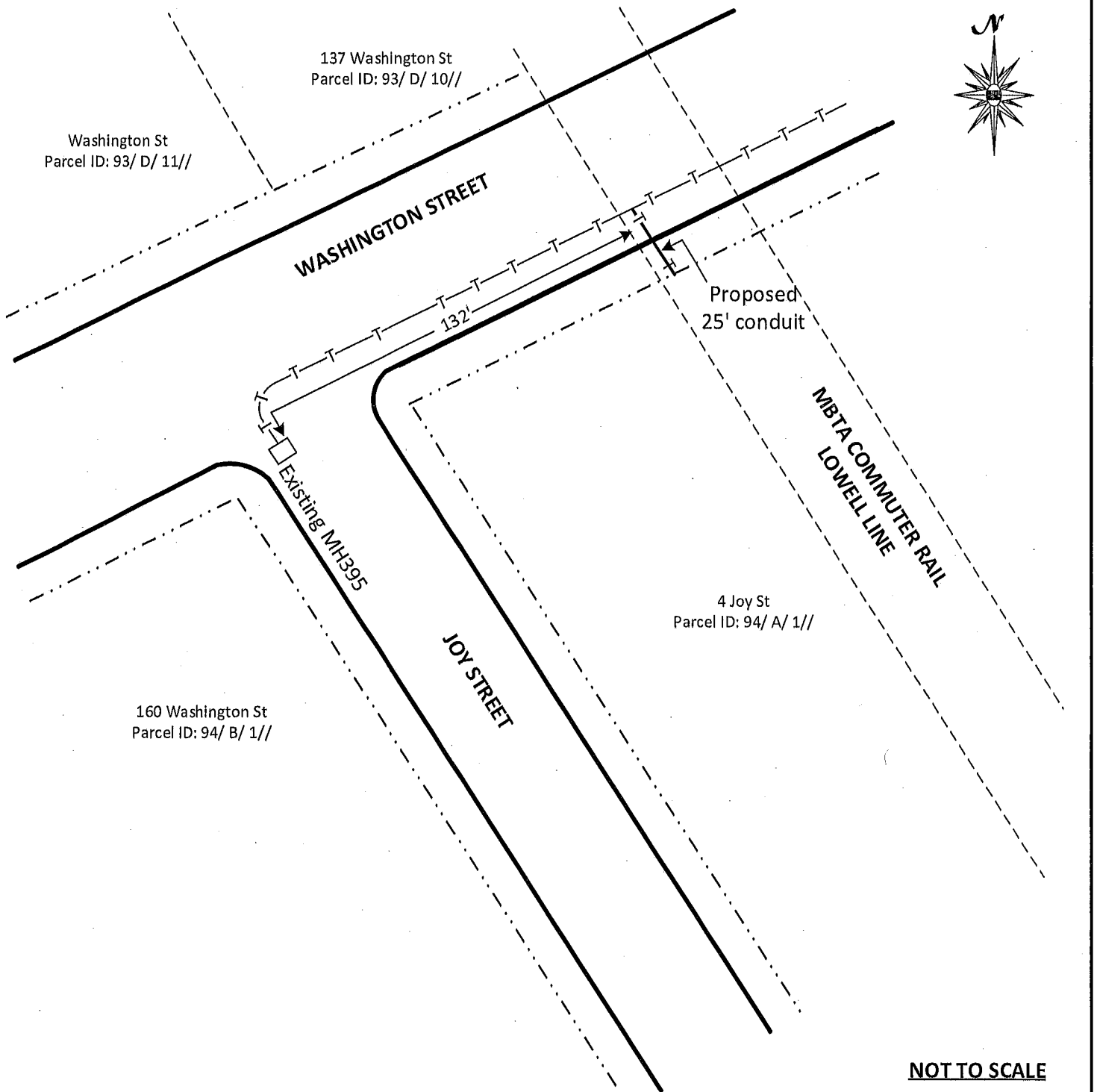

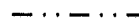
EXISTING CONDUIT



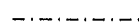
PROPOSED CONDUIT
