AMENDMENT TO LAYOUT AND ALTERATION ASSEMBLY SQUARE DRIVE AND IKEA WAY

WHEREAS, The Board of Alderman and the Mayor of the City of Somerville, Middlesex County, Massachusetts, did, under date of January 14, 2010 alter, lay out as City ways, roads known as Assembly Square Drive and IKEA Way, as shown on the plans of said City ways on file in its office, in the office of the City Clerk of said City and recorded with the Middlesex South Registry of Deeds in Book 54179, Page 325 (the "Order of Taking") and

WHEREAS, the descriptions of said layout and alteration of Sections 1 and 2 of the layout and alteration require an amendment due to design changes subsequent to the Order of Taking;

WHEREAS; it is deemed necessary to amend the said Order of Taking;

NOW, THEREFORE, it is hereby ordered that said Order of Taking be amended by striking out, Pages 1 through 5, and substituting therefore the following:

NOW, THEREFORE, acting under the authority of Chapter 82 of the Massachusetts General Laws and acts in amendment thereof and in addition thereto, the City of Somerville adjudges that public necessity and convenience require said City should alter the location of said City ways in three sections and should lay out and take charge of said City ways as altered as hereinafter described.

SECTION 1

The easterly location line of the first section hereby laid out begins at a point on the easterly location line of the Fellsway (Route 28), said point being 209.56 feet northerly from the intersection of Middlesex Avenue and the Fellsway (Route 28) and extends thence, leaving said location line by a curve to the left of 99.00 feet radius 69.10 feet (not tangent to line back); thence S 65°59'51" E 16.42 feet; thence S 14°44'34" W 7.10' feet; thence S 65°59'54" E 330.99 feet; thence S 56°36'28" E 328.00 feet; thence S 33°23'34" W 20.00 feet; thence by a curve to the right of 351.00 feet radius 62.15 feet (not tangent to back line); thence by a curve to the left of 149.00 feet radius 75.34 feet; thence by a curve to the right of 63.00 feet radius 56.12 feet; thence by a curve to the left of 99.00 feet radius 66.56' feet; thence S 23°39'19" W 26.64 feet; thence S 11°57'00" E 16.56 feet; thence N 57°19'48" W 13.20 feet; thence S 78°03'36" W 28.80 feet; thence S 11°56'24" E 371.04 feet; thence N 78°03'36" E 23.25 feet; thence S 11°56'24" E 60.92 feet; thence S 78°03'36" W 6.09 feet; thence S 33°03'36" W 24.27 feet; thence S 11°56'24" E 261.34' feet; thence S 56°56'24" E 21.19 feet; thence S 78°03'36" W 8.26 feet; thence S 11°56'24" E 57.22 feet; thence S 78°03'36" W 23.25 feet; thence S 11°56'24" E 270.59' feet; thence S 56°56'24" E 26.47 feet the point of ending thereof, said point being on the northerly street line of Foley Street.

The westerly location line of the first section hereby laid out begins at a point on the easterly location line of the Fellsway (Route 28), said point being 79.51 feet northerly of the intersection of Middlesex Avenue and the Fellsway (Route 28) and extends thence, leaving said location line by a curve to the right of 88.00 feet radius 66.85 feet (not tangent to the line back);

thence S 65°59'54" E 165.22 feet; thence by a curve to the right of 1567.00 feet radius 50.19 feet; thence again by a curve to the right of 60.00 feet radius 46.35 feet; thence S 19°53'54" E 66.34 feet; thence N 78°12'12" E 59.74 feet; thence N 54°41'30' 17.66 feet; thence S 57°33'49" E 41.31 feet; thence by a curve to the left of 2007.00 feet radius 164.80 feet; thence by a curve to the right of 225.00 feet radius 32.99 feet; thence again by a curve to the right of 100.00 feet radius 73.18 feet; thence S 11°56'24" E 99.84 feet; thence S 23°43'13" E 36.62 feet; thence by a curve to the right of 191.00 feet radius 39.27 feet; thence S 11°56'24" E 1063.00 feet; thence by a curve to the right of 20.00 feet radius 31.41 feet (non-tangent to back line) to the point of ending thereof, said point being on the northerly street line of Foley Street.

SECTION 2

The second section of city way hereby altered and laid out provides a location for the alteration and relocation of a section of existing Assembly Square Drive and the laying out of new street to be known as Ikea Way and is bounded northerly by Foley Street, westerly by Assembly Square Drive, southerly by Mystic Avenue and by the following described lines:

The easterly location line of the second section of city way hereby altered begins at a point on the southerly street line of Foley Street at the southeasterly intersection of Assembly Square Drive and Foley Street and extends thence along Foley Street along a curve to the right of a 34.00 feet radius 20.51feet (non-tangent to line back); thence along said street the following two courses, N 11°57′10″ W 6.03 feet; thence N 78°03′00″ E 292.63 feet; thence leaving said street line S 11°57′10″ E 12.78 feet; thence S 78°03′36″ W 67.92 feet; thence S 11°57′10″ E 7.25 feet; thence S 78°03′36″ W 5.30 feet thence; S 11°56′24″ E 446.25 feet; thence by a curve

to the left of 20.00 feet radius 14.85 feet; thence again by a curve to the left of 39.00 feet radius 56.89 feet; thence N 41°57'06" E 8.32 feet; thence N 56°28'54" E 23.46 feet; thence N 45°32'46" E 105.97 feet; thence by a curve to the right of 55.50 feet radius 21.51 feet; thence N 67°44'56" E 88.47 feet; thence N 78°05'31" E 316.59 feet; thence S 11°33'55" E 40.50 feet; thence S 78°05'31" W 200.91 feet; thence S 46°16'38" W 18.38 feet; thence S 73°43'42" W 41.60 feet; thence by a curve to the left of 294.00 feet radius 54.77 feet; thence again by a curve to the left of 529.00 feet radius 303.18 feet; thence S 59°47'01" E 5.50 feet; thence S 29°15'09" W 17.61 feet; thence by a curve to the left of 28.50 feet radius 28.99 feet; thence S 39°06'59" E 34.97 feet; thence by a curve to the right of 543.00 feet radius 29.70 feet; thence S 40°04'13" E 33.64 feet; thence S 3°12'01" E 8.72 feet; thence S 41°58'46" E 260.19 feet; thence S 42°03'50" E 396.45 feet; thence by a curve to the right of 647.55 feet radius 430.55 feet; thence S 3°58'05" E 226.34; thence S 36°06'18" E 9.52 feet; thence S 14°50'54" E 46.86 feet; thence S 6°02'13" E 57.15 feet; thence S 2°37'54" E 31.00 feet; thence S 1°50'56" E 57.80 feet; thence S 0°24'45" W 124.56 feet; thence S 0°28'23" E 137.75 feet to the point of ending thereof, said point being on the northerly street line of Mystic Avenue.

The westerly location line of the second section of city way hereby altered begins at a point on the southerly street line of Foley Street, said point being at the southwesterly corner of the intersection of Assembly Square Drive and Foley Street and extends thence;

N 78°02'50" E 120.71 feet; thence by a curve to the right of 20.00 feet radius 31.42 feet; thence S 11°56'24" E 374.80 feet to the point of ending thereof, said point being on the easterly street line of existing Assembly Square Drive.

SECTION 3

The third section of city way hereby altered and laid out provides a location for the widening of a portion of Assembly Square Drive on the westerly side thereof at its intersection with Mystic Avenue and is bounded easterly by Assembly Square Drive, southerly by Mystic Avenue and by the following described line:

Beginning at a point on the northeasterly street line of Mystic Avenue, about 4 feet from the northwest intersection of Mystic Avenue and Assembly square Drive and extends thence, N 46°28'25" E 80.35 feet; thence N 3°33'06" E 94.35 feet to the point of ending thereof, said point being on the westerly street line of Assembly Square Drive.

The locations of the sections of city ways altered and laid out as hereinbefore describe are to be further defined by bounds set thereon at angle points, points of curvature and at the points of beginning and ending thereof, where feasible.

For the purpose laying out, constructing and maintaining the sections of city ways hereinbefore described, the Board of Aldermen and the Mayor, on behalf of the City of Somerville under the provisions of Chapter 82 of the General laws, and all other general or special laws thereto enabling, do hereby take in easement and layout as a public way, those parcels of land shown on the plan hereinafter referred to as Parcels E-1, E-2, E-3, E-4A, E-4B, E-4C, E-5 and E-6.

The city ways hereby laid out and altered are shown on a plan prepared by Vanasse Hangen Brustlin, Inc. dated January 13, 2011, which is recorded herewith and entitled:

"PERMANENT HIGHWAY EASEMENT AMENDED PLAN OF LAND ASSEMBLY SQUARE DRIVE FOLEY STREET & IKEA WAY IN THE CITY OF SOMERVILLE, MASSACHUSETTS MIDDLESEX COUNTY SCALE: 1" = 80 FEET"

IT IS THEREFORE ORDERED: that an easement for roadway purposes be and hereby is taken in Parcels E-1, E-2, E-3, E-4A, E-4B, E-4C, E-5 and E-6, and that said city ways as laid out and altered, as described herein, and as described and shown on said plan, be and the same are hereby laid out and taken charge of by the City of Somerville.
