Identify criminal offenders, apprehend when necessary, and participate in subsequent court proceedings as required.

Safeguard monies and securities from University/Hospital and Federal repositories to and from the bank, and furnishes escort services as required.

Report punctually to all assignments and responds immediately to all emergencies.

Assist in a courteous manner all persons seeking directions, information or assistance.

Secure and properly records all evidence or other property coming into their custody.

Ensure that all prisoners in their care and custody are safely transported and processed in accordance with Divisional Policies/Procedures

May provide emergency first aid upon the lands of the University/Hospital and call for professional assistance as required. Transports sick/injured persons to the hospital when necessary, or to the appropriate medical facility.

Arrest or issue citations for federal offenses, including violations of the UCMJ and Title 18 USC (including the Assimilated Crimes Act/13), whether ongoing or after the fact, and use verbal de-escalation techniques in volatile situations.

Conduct investigative interviews and take sworn statements from complainants, witnesses, victims, and suspects of all crimes in

jurisdiction and in my purview. During these interviews, sensitive information, allegations, and hearsay is presented and thoroughly investigated. Protecting civil rights of the accused during these procedures is critical.

Prepare written police reports utilizing agency approved databases, complying with agency instructions for referral, timely resolution, and closure. Ensure accuracy by correcting errors and inconsistencies.

Included in reports: witness and victim statements, evidence gathered, forms completed, brief summary of investigation in report narrative and photographs taken.

Secure facts and gather evidence in support of current investigations. Draw correct conclusions from all available data by gaining the trust of suspects and discerning truth from written and verbal statements. Determining if violations of law occurred are made based on the totality of circumstances.

Maintain liaison with key stakeholders/other law enforcement entities such as local police, OSI, CID, NCIS, suspect, witnesses, victims, and their relative military leadership. Work with internal and external groups, such as members of police unions or command structure of suspects, witnesses and victims, to ensure understanding and coordination in response to incidents.

Discern integrity from individuals during interviews related to crimes committed, to include utilizing information from various resources, including local law enforcement databases, social media, internet searches, and national databases such as NCIC (National Criminal Information Center) and CJIS (Criminal Justice Information Systems).

Properly seize, log, control, transport and transfer all evidence gathered from crime scenes. Receiving only items of evidentiary value related to the crimes committed. Secure and protect integrity of crime scenes.

Coordinate with and report initial scene conditions to oncoming criminal investigators for offenses not within the scope of my duties as a patrol officer.

Develop information by using active listening and follow up questions when on scene of a crime, during interviews, and other incidents.

Receive reports of crimes committed, maintain key control inventory, and review police reports. Prepare police reports and maintain desk journals, compiling criminal statistics and ensuring they are accurate and completed in a timely manner.

Create and maintain log, police notebook, and journal entries of

events on unusual circumstances and conditions (suspicious activity, BOLO's, Eagle Eyes Reports, Field Interviews, et cetera).

Conduct investigations of minor incidents and felonies on military installation to ensure order and safety of all personnel. Thefts, intrusion alarms, assaults, minor traffic accidents, domestic violence, and other violations of the Uniformed Code of Military Justice (UCMJ), Title 18 or other United States Codes (USC), and Massachusetts General Statutes are examples of incidents responded to.

Patrol military installation utilizing police vehicles and other law enforcement equipment (breathalyzer, night vision goggles, thermal imaging devices, vehicle mounted radar devices) to ensure the safety of

All personnel and government property using appropriate Force Protection measures and police procedures.

Reference relevant federal, state, and local laws during incidents and educate subordinate and peer officer's on proper procedures expected from the agency. Ensure the organization follows federal guidelines set by rules, regulations and case law which leads to conducting police business in an efficient and proper manner.

Collect DNA samples and fingerprints from suspects in accordance with agency policy and relevant law.
