195725 - That the City Solicitor provide this Board's Committee on Legislative Matters with input on restricting formula businesses in Somerville by requiring specific review and oversight before they may enter central business districts.:

Mr. Proakis discussed the zoning code, use tables, community concerns, special permit triggering points, the definition of formula business, post review findings and his desire to build a business district draft from the ground up. Ms. Graney spoke about controlling the design and square footage of businesses and the negative impact of formula businesses on neighborhoods and Mr. Grossfield discussed possible legal challenges.

Recommendations were made to circulate the proposed draft to all aldermen and the Chamber of Commerce for their feedback.

Ms. Wheeler, Ms. Field and Ms. Darai spoke about some of the issues facing transgender individuals as well as difficulties faced by businesses when checking ID's. Similar protections are in place in Cambridge, Amherst, Boston, Northampton and Salem. City Solicitor Wright recommended language for the amendment.
