Dear Board Members:

Preliminary approval is recommended for the petition and plan of NSTAR Electric and Verizon New England Inc. to relocate on the Westerly side, Pole 213/4 approximately 39' (feet) south and to install riser Pole 213/4A, which is approximately 180' (feet) from Foley Street and install approximately 7' (feet) of conduit from Pole 213/4 to point of pick up, which is approximately 265' (feet) south of Foley Street, Somerville, MA.

This recommendation is made with reference to NSTAR Electric and VERIZON's letter of May 29, 2012 and plan of May 9, 2012 upon stipulation that the Grant of Location is subject to: a reservation of rescission by the Board of Aldermen; indemnification of the City for all liability arising from said Grant; all permit procedures, conditions and approvals of municipal utilities; protection of existing infrastructure; and complete surface repair, restoration and maintenance. A public hearing will be required.

Respectfully represent **NSTAR ELECTRIC COMPANY and VERIZON NEW ENGLAND INC.** companies subject to Chapter 166 of the General Laws (Ter. Ed.), that they have heretofore received a grant of joint or identical location for, and have erected or constructed, a line consisting of wires, poles and such other fixtures as may be necessary to sustain or protect the wires of the line, upon, along and across the public way or ways hereinafter specified, and that it is desirable that the location of certain of said poles be altered.


