Preliminary approval is recommended for the petition and plan of NSTAR Electric to place ten (10') feet of conduit northerly from MH 11398 at Cross St, Somerville, MA to the point of pick up at 23-25 Cross St, Somerville, MA.

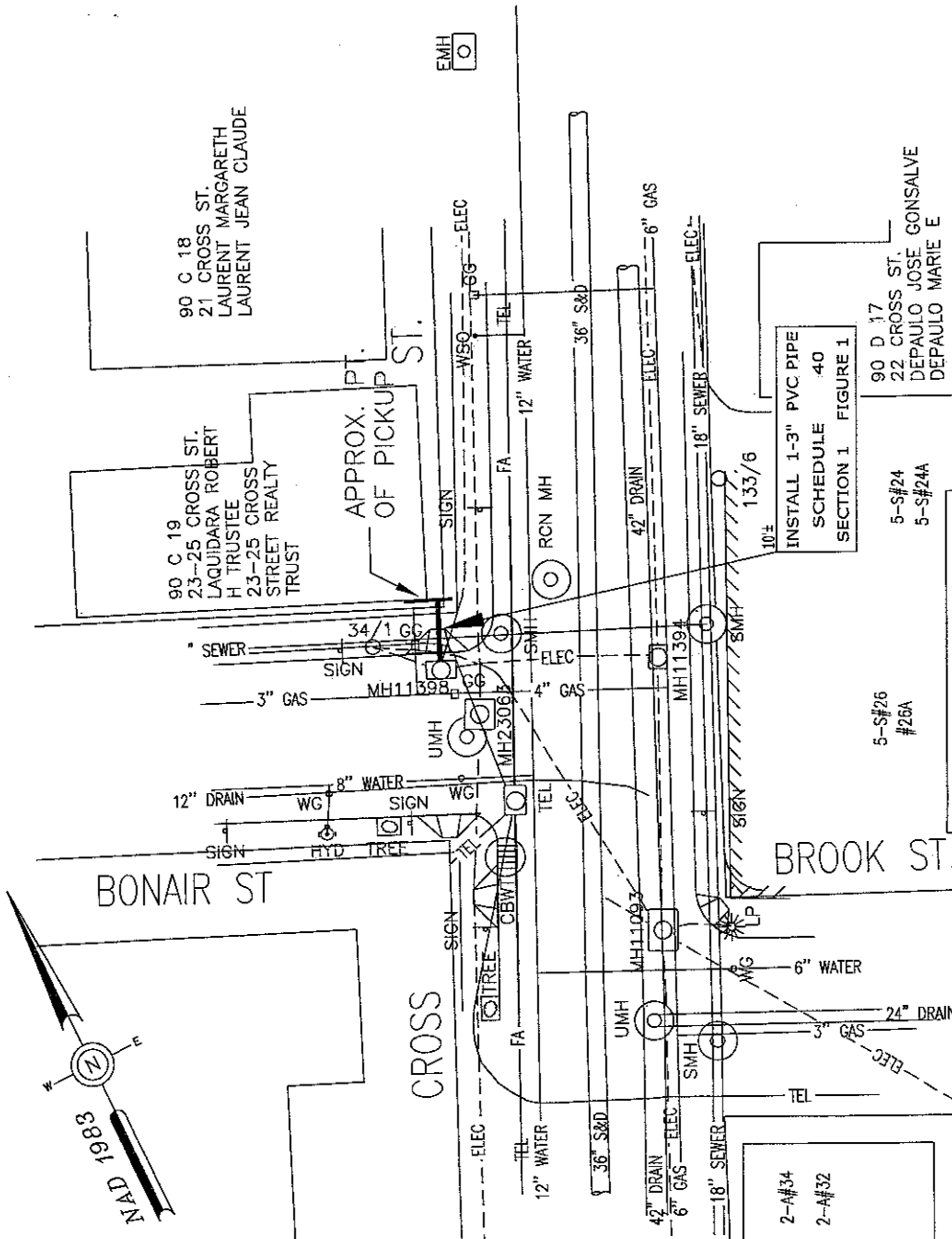


