SPOKE WITH SHEILA WHO TOLD ME WHEN HER UPBRINGING
SHE WAS A GRADUATE OF THE SCHOOLS, WENT TO SCHOOL,
AND THE EAST SOMERVILLE SCHOOL.

SHE WENT TO BC COLLEGE.

MARY WAS BORN WITH CEREBRAL PALSY AND SHE WAS A LONG
TIME MEMBER OF THE WALNUT CENTER AND SHE KEPT COMING

BACK TO, HOW ACTIVE MARY WAS IN THE COMMUNITY.
SHE WAS ALWAYS OUT HELPING PEOPLE, SHE WAS VERY
RECENTLY UP HERE AT CITY HALL.

I KNOW SHE MET MANY OF THE COUNSELORS WHEN THE CITY
COUNCIL GAVE A CITATION, ABOUT A CHILDREN'S BOOK
THAT SHE HAD WRITTEN, MARY WAS UP HERE AND SHEILA
SAID THAT MARY HAD MET WITH THE MAYOR ELECT JAKE
WILSON WHO PROMISED TO GIVE HER A TOUR OF CITY HALL.

>> HONORABLE COUNCIL I WANT TO COME BEFORE YOU TO INTRODUCE THIS, SO YOU UNDERSTOOD WHAT THIS WAS. AS PART OF GREATER REORGANIZATION WE'RE LOOKING AT DOING IN THE CITY.

WE ARE DOING A RESTRUCTURING OF THE MAYORS OFFICE. AS A RESULT WE REPURCHASE PASSED TWO NEW ROLES. THAT'S WHAT THIS IS, THIS IS THE SALARIES FOR THOSE FOLKS.

WE HAVE NOW A MARY'S PUBLIC LIAISON, JESSE MOOSE, WE HAVE A COMMUNITY PARTNERSHIPS LIAISON. AS A RESULT WE NEED MOVE SOME SALARY AROUND. SO THAT'S WHAT YOU ARE SEEING BEFORE YOU.

WE WANTED TO COME EXPLAIN THAT TO YOU AND YOU ASK IF YOU PLEASE APPROVE OF THIS TONIGHT.

THE MAYORS PUBLIC LIASON IS THE CONDUIT BETWEEN THE MAYOR OFFICE AND THE PUBLIC.

THAT ROLE IS HAS SOME SOCIAL MEDIA AND JUST MAKING SURE THAT THE PUBLIC HAS SOMEONE THEY CAN TALK TO, AND MAKE SURE THAT THEIR CONCERNS ARE RELEVANT TO THE MAYORS OFFICE AND BRING THAT COMMUNICATION RIGHT BACK TO THEM.

I FEEL IT IS VERY IMPORTANT THAT THEY FEEL CONNECTED TO THEIR MAYOR AND THIS IS A KEY PART OF MAKING THAT HAPPEN. THE OTHER ROLE, IT'S BEEN MY OBSERVATION THAT WE HAVE NOT DONE A GREAT JOB OF COORDINATING EFFORTS BETWEEN THE CITY AND MANY COMMUNITY PARTNERS.

I CAN NAME THEM BUT I DON'T WANT TO LEAVE ANYONE ELSE.

MAIN STREET ORGANIZATIONS.

WE HAVE SO MANY COMMUNITY PARTNERS WHO DO INCREDIBLE WORK AND IT WAS A REALLY IMPORTANT PRIORITY FOR ME TO MAKE SURE THAT WE ARE INVOLVING THEM AND MAKING SURE THAT WE'RE ALL ON THE SAME PAGE SO WE CAN DUPLICATE EVERY, TO MAKE SURE THAT WORK IS GETTING DONE. THAT'S WHY IT IS SO IMPORTANT.

MR. PRESIDENT, FOLLOW-UP ON THAT, TO MARY WILSON.

THANK YOU FOR THAT.

WITH THIS SOCIAL MEDIA WORK OF THE PUBLIC EXECUTIVE LIAISON DOING THAT, WILL THAT BE IN THE COMMUNICATIONS DEPARTMENT OR IS THAT A SEPARATE ENTITY?

CAN YOU JUST QUICKLY DESCRIBE THE NECESSITY OF SEPARATING THAT IF IT IS SEPARATE FROM THE COMMUNITY DEPARTMENT THE PURPOSE OF THAT THROUGH THE PRESIDENT, I THOUGHT IT WAS IMPORTANT THAT THESE MAYORS SOCIAL MEDIA ACCOUNT IS THE VOICE OF THE MAYOR. FOR EXAMPLE, WHEN VIDEO OF THAT YESTERDAY, ANNOUNCING THAT CHAPTER 40 B FILING WAS DONE IN DAVIS SQUARE WE GOT A LOT OF GOOD FEEDBACK ON THAT. I THINK IT'S VERY IMPORTANT FOR YOU TO CONNECT WITH PEOPLE AND GET THE WORD OUT TO THE COMMUNITY.

WE'RE GOING TO BE LOOKING TO DO MUCH MORE OF THAT.

THERE'S COORDINATION WITH THEM ON ANYTHING ON THE SOCIAL MEDIA SIDE.

I JUST THOUGHT IT WAS IMPORTANT TO HAVE THAT DIVIDE BETWEEN THE MAYOR'S SOCIAL MEDIA ACCOUNT AND THE CITY, BECAUSE WE HAVEN'T ALWAYS SEEN THAT CLEAR DIVIDE IN THE PAST.

HOWEVER THERE'S A LOT OF WORK THAT HAS BEEN DONE ABOUT THIS.

THAT CAN BE OUTSIDE OF AN ORDER. THERE'S A LOT OF GOOD WORK.

A LOT OF CONVERSATION, HAPPENING AS WHEN.

SO I AM EXCITED TO TALK ABOUT ADUS AND COTTAGES AND WHAT THE NEXT YEAR AND YEARS TO COME WILL LOOK LIKE. LET'S RESEARCH THE WORK AND LISTEN.

THROUGH THE CHAIR, THANK YOU AND FIRST I WANT TO ALSO APPRECIATE MY COLLEAGUE, AND YOUR POINT ABOUT DOING HOMEWORK BEFORE WE BRING ORDERS, AND I APPRECIATE EVERYONE'S GRACE AND PATIENCE AS I GET UP TO SPEED.

THIS IS AN IDEA THAT WAS BROUGHT UP BY SOMEONE ELSE TO ME.

I DON'T WANT TO CLAIM THAT IT'S MY IDEA, BUT I THINK IT'S PROMISING.

SO MANY PEOPLE HAVE OBSERVED IN SOMERVILLE, AND SO MANY OTHER PLACES, THERE SEEMS TO BE A LOT OF DIVISION, AND PERHAPS MORE THAN THERE USED TO BE. BUT ITEMS SUBMITTED OR THE SUPPLEMENTAL ITEMS.

THAT IS PUBLISHED IN THE MORNING.

THURSDAY MORNING.

AS I SAID THERE'S BECAUSE THE OPEN MEETING LAW SAYS ANYTHING THAT CHAIR BELIEVES WOULD BE DISCUSSED WITHIN 48 HOURS, SHOULD BE ON THE AGENDA.

CASE, LAY IT ON THE TABLE OR SEND IT TO COMMITTEE.

>>> SEND IT TO COMMITTEE.

>>> WE'LL SEND THESE TO COMMITTEE WITHOUT AN ACTION.

SO THAT WILL BE REFERRED TO COMMITTEE.

THAT WAY THE COUNCIL IS NOT TAKING AN ACTION ON THEM.

IF AND WHEN THEY GO ON THE AGENDA, THE PUBLIC WILL BE AWARE OF IT AND THEN, WE CAN DELIBERATE.

SO THAT'S JUST A LITTLE INSIDE BASEBALL EXPLANATION FOR EVERYTHING.
