How have you spread the word about the work of the Somerville Commission for Women?

• Why do you want to continue to serve on the Commission?

I thought the Commission was falling apart during the absence of an executive director over this past year but I believe that absence will make for a stronger Commission moving forward. I believe the women that are left on the Commission are serious and also excited to grow. I feel that we're rebuilding the Commission at this time and it's an honor to be a part of it. We have a lot of projects that need attention, and I think once we're a full commission again, and able to meet quorum, we'll be able to focus on providing the community with more, whether it be informational events, support, etc.

• Can you tell us how your personal and/or professional experience has enriched the Commission?

I'm very social and I like to have fun no matter what I'm doing. Although I think I've brought other things to the Commission I believe my enthusiasm has been my biggest contribution. It may sound silly but I don't remember going to many meetings in the past where people seemed very excited to be there. There would be a simple exchange of hellos amongst people, and then we'd get started. I'm serious about getting things done, but I'm a strong believer in getting things done with a smile. As a business owner I would never greet a client without a smile and I know a little something about each and every one of them. At meetings now everyone knows a little bit about everyone else, because we all chat, and most of the Commissioners exchange hugs upon entering and exiting. Of course I'm not the main reason for this but I truly think my high fives helped out. And because the Commissioners are happy, we work better together, and can therefore serve the community better.

Aside from my enthusiasm, I'm goal oriented, very organized and I love party planning. I don't mind helping meetings to get back on track when discussions go off agenda. I can help plan any event we're organizing/helping to organize.

• What have you gained from serving on the Somerville Commission for Women?

I've definitely gained a better understanding of city official roles while serving as a commissioner. It may not be the importance of the question but I find the different roles in the community fascinating. I'm not a person that likes discussing politics and I'm therefore not very interested in what's happening with government roles but I have been a lot more interested since joining the commission. I've learned about and have come to appreciate some local programs and organizations that focus on women's rights.

• What three issues concerning the Somerville Commission for Women would you identify as your top priorities?

I think my biggest concern with the Commission at this time is its ability to meet quorum. I'm sure this can explain itself but my main concern is we can't discuss our agenda without quorum and that leaves us at somewhat of a standstill. Although I think quality wins over quantity I'd like to see us focus our efforts on finding new commissioners. I suppose the key here is to find passionate Commissioners, that will come to meetings each month and have an opinion when it matters.

I'd like to focus our efforts moving forward on involving the community more. A few commissioners have mentioned events such as us sponsoring a car seat check. Something like this would need some planning and volunteer time from Commissioners, but this could help increase public awareness about the commission. While increasing public awareness we'd also be working on important issues.

Lastly, I'd like to see the Commission focus on supporting more local projects. In the past the executive

director handled most of the Commissions needs, which made it get difficult for me to get too involved. I'm sure there was more I could have done to involve myself but I didn't always understand what our role was. With the current status of the Commission, assuming we're able to meet quorum in the next few months, I feel confident the Commission will meet it's potential this year.
