### TERMINATION AND RELEASE OF EASEMENT

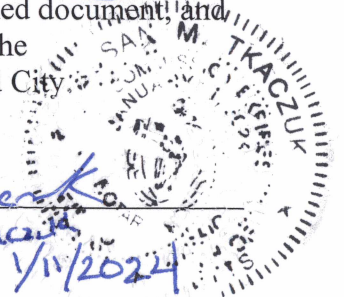


EXHIBIT A
