Dear Councilors,

I am a longtime resident of Somerville, and as a Jewish Israeli-American who has been working to oppose occupation throughout my adult life, this past month has been hell. Watching my loved ones attacked brutally beyond words on October 7th, and seeing the hellfire of revenge rained down on Gaza in response, has been unbearable. I believe that a ceasefire is an absolute necessity to protect both Palestinians and Israelis- there is no military solution to this conflict. The longer this aimless war in Gaza- at best ethnic cleansing at worst genocide- is allowed to continue, the more any final hopes for a true solution to the conflict slip away. Yet American leaders on the national scale by and large have staunchly refused to lead, have refused to put pressure to end this conflict. That's why I am writing to express my sincere hope that Somerville will introduce and pass a resolution in support of an immediate ceasefire similar to this one that you likely have seen proposed in Cambridge.

Far too many of our leaders on the national level are not listening. They remain committed to policies that will only bring more bloodshed for decades to come or more. But on October 20th, a Data for Progress poll found that 66% of U.S. voters "strongly agree" or "somewhat agree" with the U.S. leveraging its close diplomatic relationship with Israel to prevent further civilian death by calling for a ceasefire and de-escalation of violence in Gaza. More recent polls suggest that number is growing. And that number skyrocketed to 80% among Democratic voters, who make up the majority of our community.

I have heard that there are efforts to introduce such a proposal here in Somerville. I sincerely hope this is true and encourage you to push for such a resolution here. We need something to provide hope. We need something to put pressure on our national leaders. Please help Somerville be part of that movement.

Dear President Biden and Secretary Blinken,

We write to you to express deep concern about the intensifying war in Gaza, particularly grave violations against children, and our fear that without an immediate cessation of hostilities and the establishment of a robust bilateral ceasefire, this war will lead to a further loss of civilian life and risk dragging the United States into dangerous and unwise conflict with armed groups across the Middle East. Further, we write urging clarity on your strategic objectives for achieving deescalation and stability in the region.

We reaffirm our unequivocal condemnation of the Hamas attacks on Israel that took place on October 7th, in which Hamas killed over 1,200 Israelis and foreign nationals, and captured over 200 hostages, who were subsequently taken to Gaza. While exact figures have not yet been released, Israeli authorities so far have confirmed the identity of 846 civilians killed, including 31 children, and at least 20 children who have been abducted by Palestinian armed groups.¹

We also share dire concerns with the ongoing Israeli response, in which the Israeli Defense Forces have killed over 11,078 Palestinians, nearly half of whom have been children. During the past 39 days of hostilities, at least 4,506 children have been killed in the Gaza Strip and at least 7,695 children have sustained injuries. Additionally, about 3,250 Palestinians in Gaza, including at least 1,755 children, have been reported missing and are presumed to be trapped or dead under the rubble, awaiting rescue or recovery. During this same time, Israeli forces or settlers have killed 51 Palestinian children in the occupied West Bank. ^{4 5 6}

We are profoundly shocked by the grave violations of children's rights in the context of armed conflict in Israel and the Occupied Palestinian Territory. International norms require that all parties to an armed conflict protect children and prevent the commission of grave violations against them, including killing and maiming, attacks on schools and hospitals, recruitment and use of children, abduction of children, and denial of humanitarian access.⁷

Of the total 2.2 million Palestinians living in the Gaza Strip, nearly half are children. In addition to the threat of widespread Israeli airstrikes on residential buildings and civilian infrastructure, these children face further imminent threats due to Israeli government restrictions on food, water, fuel, and other humanitarian assistance being able to reach these children and their families. To date, 285 Educational facilities in Gaza have been affected, including at least 29 United Nationsrun schools. Eight of these schools were used as emergency shelters for internally displaced people in Gaza, with at least one of them being directly hit in an Israeli airstrike. Two thirds of medical facilities in the Gaza Strip have completely shut down, according to the World Health Organization, including 22 out of Gaza's 35 hospitals. Additionally, Israel has now carried out multiple strikes on five refugee camps inside Gaza, resulting in civilian casualties.

We commend your Administration's goals of seeing a major expansion of humanitarian supplies arriving into Gaza. While we greatly welcome your work, it has had limited impact on the ground so far and, we believe, risks undermining the United States' own credibility in the region. We urge an immediate cessation of hostilities in order to stop the bombing and provide much-needed relief to Palestinian civilians.

In his remarks reflecting on the October 7th attacks, the President acknowledged U.S. mistakes in the aftermath of September 11th and advised that an appropriate response "requires being deliberate. It requires asking very hard questions. It requires clarity about the objectives and an honest assessment about whether the path you are on will achieve those objectives." These wise words should continue to inform U.S. counsel to Israel's response. Recognizing that there is no military solution that will end the Israeli-Palestinian conflict, we urge your Administration to obtain clarity on the specific strategic objectives of a large-scale ground invasion, their achievability, what may come after Hamas, the risks to hostages and civilians in the region, the

national security implications of a multi-front war in the Middle East, and the potential threats to American citizens in the region.

We thank the President for calling for a humanitarian pause so that humanitarian aid may flow and diplomacy may take place. However, given the present lack of an apparent and clear strategic plan, we encourage a redoubling of efforts to achieve rapid de-escalation through a ceasefire and robust, regional engagement that includes international humanitarian organizations. We understand that the Administration has serious concerns regarding the objectives and consequences of a large-scale ground offensive, and we urge you to press this case directly.

Thank you for your time and consideration, and we look forward to your response.
