• The city trash crews will pick up ONE piece of furniture per week. Remember, it's heading to the landfill or incinerator if you choose this route, so, if it's usable and is in good condition, please see what you can do to arrange a rescue! If it's a ripped, torn, stained, about-to-fall-apart mess...unfortunately it probably is trash!

You can see from the attached photo there is a very obvious free label.

The irony is that I took it in to my garage (where it is still sitting - waiting for big brother, big sister) the night before trash collection because I did not want it to get damaged

So now I know not to try and recycle. If this is the new approach in Somerville I want to go and and tell everyone that the old recycle days are gone in as public a manner as I can.

I'm not aware of any specific or unusual activities that would discourage the practice. With that said, we want to make sure that we avoid creating access (ADA), litter and blight issues. What may happen is if items linger on the sidewalk for an extended period of time, 311 may get a complaint about abandoned furniture that the city would have to act on. Otherwise, the city's trash and recycling hauler will pick up those items on their assigned pick up days.

Please let me know if you have observed otherwise.
