The commission's decisions and basic merit principles outlined in the Personnel Administrations rules prohibit the arbitrary and capricious rejection of a candidate, including for political reasons, and demand a standard of "neutrally applied public policy" as guidance for our review. Committee members are encouraged to adhere to this standard while considering all candidates, regardless of civil service status.
