To Whom It May Concern:

In order for us to maximize the number of usable seats during the cold months, we need to seat guests very close to the door. We do utilize a floor to ceiling velvet curtain between the door and the dining room, but we continued to receive complaints about the wind rushing into the building when the door was opened. We had a custom vestibule constructed by Atlantic Awnings in 2018 so that the dining area could never be directly exposed to the elements.

The dimensions of the vestibule were designed by Atlantic Awnings to be ADA compliant and to maintain a wide, passable sidewalk for pedestrians, bicycle storage and emergency responder. The frame is galvanized steel with welded corners, and the covering is Firesist, a flame retardant awning specific material. The vestibule is anchored both the ground and the facade of the building. The structure maintained its integrity through the winter months. It was removed the last week of April and stored for the season.

The vestibule only had positive benefits for Spoke Wine Bar. Weatherizing our business meant lower heating bills and increased sidewalk visibility. We have not had any negative feedback regarding the vestibule. We have only received encouraging feedback from the community for being innovative with our small space.
