Dear Mr. Long:

Pursuant to MGL Chapter 166 Section 22, NSTAR Electric Company d/b/a Eversource Energy (hereinafter the "Petitioner"), a company incorporated for the transmission of electricity for lighting, heating or power, hereby submits this Petition for a Grant of Location ("GOL") to the City of Somerville, MA. See attached Exhibit A. The Petitioner respectfully requests the City of Somerville by order to issue the GOL to the Petitioner for construction of a new electric transmission line within public ways as provided for herein. See attached Exhibit B. As required, enclosed with this submission is a payment of the application fee \$605.00.

Project Description

The project consists of a new subsurface 115 kilovolt transmission electric pipe type cable ("PTC") circuit with appurtenant communication/signal wires to be installed beneath various public ways in the City of Somerville. See attached Exhibit C for a 1"=500' scale locus map of the project. The PTC is comprised of three electric conductor cables inside of an eightinch (8") ductile steel pipe. The communication/signal wires will be contained inside two (2) four-inch (4") PVC conduits.

Project Route

In the City of Somerville, the underground project route commences at a point under Mystic Avenue at the end of the jurisdiction of the Massachusetts Department of Transportation (MADOT) southeasterly of the intersection of Middlesex Avenue and proceeds southeasterly approximately 1,925 linear feet (lf) to the intersection with Alfred A. Lombardi Way. Thence the project route continues southeasterly beneath Alfred A. Lombardi Way approximately 81 lf to the intersection with the MADOT I-93 layout. See attached Exhibit D for a 1"=300' scale layout map of the project.

Grant of Location Request Mystic-Woburn Reliability Project

Project Design

The ductile steel pipe and PVC conduits will be positioned in an approximately 24" x 26" "duct bank" infilled with fluidized thermal material. The duct bank will be installed in an excavated trench that is approximately 24"wide and 60"deep. The duct bank will typically have approximately 34" of cover to finished grade. See attached Exhibit E for plan and profile drawings for the proposed duct bank, duct bank cross section data, trench backfill specifications.

Municipal Permits

Upon issuance of the requested GOL, Eversource's Project Contractor shall obtain all required local municipal permits prior to beginning work within the city (e.g. street opening, curb cut, trench permits, etc.). The Contractor shall work with the city's engineering and public works departments to ensure that all disturbances to the public are avoided and/or minimized to the greatest extent possible. As part of the effort to reduce disturbance resulting from the proposed activities in the public way, temporary traffic control plans have been prepared. See attached Exhibit F for these plans. Additionally, Eversource will provide contact information for appropriate Eversource and Contractor personnel for use by city officials and concerned citizens during construction activities. Lastly, please see the attached Exhibit G for a list of abutters with enclosed mailing labels.

As such, Eversource respectfully requests the city to issue a Grant of Location as set forth above. If you have any questions or require additional information, please contact me at your earliest convenience.






