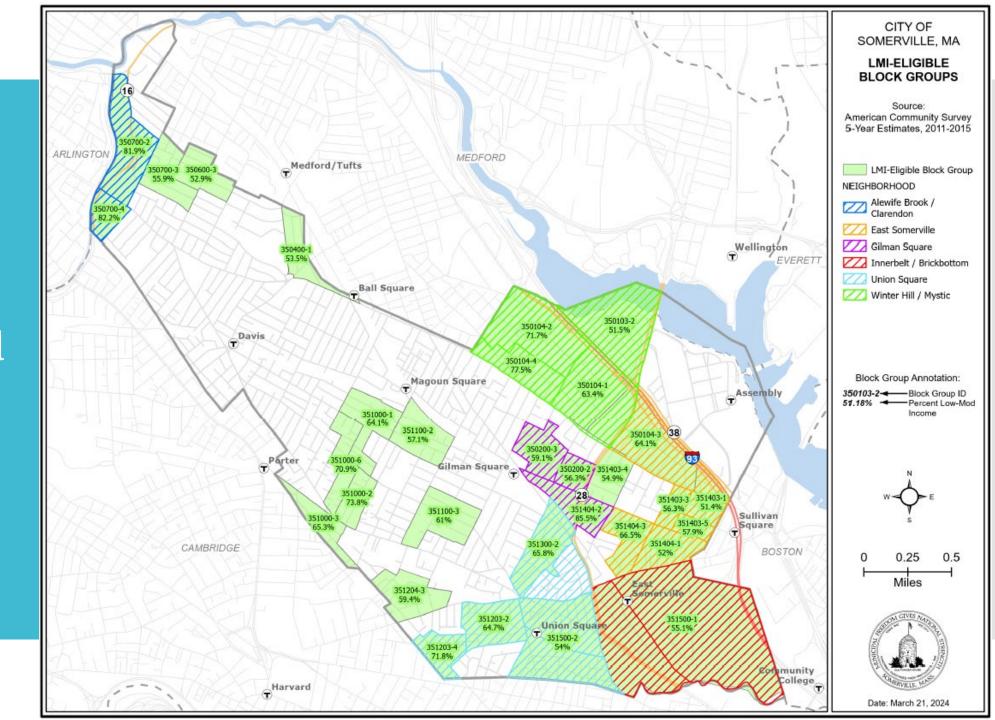

- Allows Somerville to borrow from HUD up to 5x its annual entitlement
- Evaluating Section 108 to advance affordable housing development projects
 Will likely be used on Clarendon Hill Redevelopment
- A successful project would be paid in annual installments from future years' entitlement
- Estimated \$400k annually until paid off
- City is amending its Community Participation Plan to include public comment provisions for any future borrowing
