Please find attached additional information regarding the information request for orders 24-0389, 24-0388, 24-0097, 24-0096, 24-0093, 24-0387, 24-0384, 24-0094, 24-0386, 24-0095 and 24-0385.

Items 24-0093 through 24-0097, and 24-0384 through 24-0387

The documents submitted on 3/20 provide a list of all of the complaints that have been received for the properties requested in items 24-0093 through 24-0097 and 24-0384 through 24-0387. As shown by the complaints received, there have not been a significant number of recent complaints and those that were received have been addressed appropriately.

Item 24-0389

Attachment A provides a description of how the department tracks, organizes, and addresses complaints. The attachment includes a data overview of tickets issued by ISD between 1/1/2020 until 3/31/2024. In that timeframe ISD has issued 18,151 tickets with a total fine amount of \$2,297,920. 13,606 of which are trash related.

Although trash ticketing takes up a significant portion of ISD efforts, there are several other laws, regulations, and ordinances for which ISD is charged with enforcement. As a further supplement to 24-0389, Attachment B provides an overview of the laws, regulations, ordinances, etc. that ISD enforces, to give a scope of duties in addition to trash violations.

Item 24-0388

Attachment C provides the list of properties that have submitted applications to register as a vacant property and any tickets associated with these properties. There are several issues hindering effective implementation of the Vacant Property Ordinance as written. The ordinance itself does not incentivize vacant property owners to register their properties and includes broad requirements for maintenance. These issues, in combination with a lack of resources to properly implement such an ordinance, make effective, proactive enforcement a significant challenge.





Item 24-0469

The dark skies requirements are located within the Somerville Zoning Ordinance, which puts constraints on enforcement. First, any application submitted or building constructed prior to 2020 is not subject to enforcement of dark sky requirements, as any violations would be considered pre-existing conditions. For applications received after 2020, the requirements have been reviewed and projects have been made to comply. However, projects have appealed ISD determinations regarding the dark skies requirements to the Zoning Board of Appeals and have received relief from these requirements.





ATTACHMENT A – FINES ORGANIZATION, PROCESS, AND DATA

Ticket Process Overview

ISD utilizes the Citizenserve cloud-based software to administer code cases as well as review and issue the various permits and licenses within its purview.

For Code cases, this enables uploading and retention of violation photos and other supporting documentation which ISD inspectors will input. It organizes case assignments, inspection status classification, and notes for inspections and generating template forms, such as violation notices/orders, and tickets.

When a Code case is created it is assigned a unique file number. Records for a code case are organized within that file number at the simplest level. The software enables searching of multiple fields to locate relevant case files, the most frequent/useful being address.

If ISD receives a complaint directly by email, phone, or in person it is manually entered into the system by ISD staff and routed for assignment and follow up action. Most complaints come through the 311 Qalert system, which integrates with Citizenserve, and allows certain cases to transfer back and forth between the two systems.

Tickets generate off of a customized 'ticket activity type' form that is filled out by an inspector after they have observed and documented a violation within a code case file.

ISD has the ability to issue municipal ordinance tickets in accordance with MGL c 40 s. 21D for specific code sections or Building Code Tickets pursuant to MGL c. 148A s. 2. Each ticket activity type has various informational field requirements to be entered in accordance with their enabling legislation.

At the simplest level, both ticket activity forms require the inspector to select the applicable violation code (the section of the ordinance or regulation from the 'Violation Types' database created within Citizenserve), freeform comments which will appear on the ticket, and enable the inspector to link violation photos to the ticket (that can be used as a reference for the municipal hearing officer, should the tickets be appealed).

Property owner and address information will automatically populate if the ticket is being generated out of a case file with a valid parcel address. For effective code enforcement it is integral ISD be provided valid property addresses when receiving complaints. This enables ISD to be efficient in investigating the correct properties and enables the City to lien the property, should the tickets go unpaid. Tickets generated off of an invalid parcel address cannot be liened.

Violation codes to be utilized for tickets are input into the 'Violation Types' database in Citizenserve. Violation Types contain fields of information of the code citation (such as SCO 11-031 for residential trash), a short description of the violation type, the fine amount for the citation, and a full description of the citation if applicable (usually the full code section text). For violations that have escalated fine amounts (1st offense, 2nd offense etc.), a code entry is needed for each fine amount.

When ticket violation codes are created in the 'Violation Types' database in Citizenserve, ISD coordinates with IT and the Clerk's office to ensure accuracy of codes, fines, and descriptions for proper collection or lien if not paid (if applicable).

When a ticket is generated in the Citizenserve system it creates the ticket in the Code Enforcement case file to be served by ISD and simultaneously creates a Ticket file for the Clerks office to track for collection, appeal, demand, and/or lien purposes.

Ticket reports can be generated out of Citizenserve that will contain details of the ticket which can be exported into an excel spreadsheet format. Ticket reports can be run by field including, date issuance range, address, or violation type.




