





311 Reports Per Ward



311 Calls by Ward throughout Year






Note: Color scales


All Complaint Inspections and Residential Program Participants

Residential Program Visits by Week 2022








The SMART Pilot Program Phase I is complete!

- Promising results: ~900 Captures with data being used to target area specific causes of rodent activity.
- Identification of inactive area types and higher activity areas to inform future efforts.
- Avoided rodenticide usage on these rodents will only positively impact the local environment long-term.



What the data shows



March	April	May	June	July	August	September	Total
18	168	147	216	210	61	93	913

What we learned!

- * High concentration of rats in/around commercial dumpsters
- * Locations abutting the GLX and the capture data further confirms that the City must work closely with the MBTA and other major construction/demo. sites.
- * Mixed use spaces residential + business should be areas of focus as well
 - * Access to residential waste
 - * Access to commercial waste
 - * Access to shelter
- * We are working with Modern (Anticemex) on developing a more real-time data tracking service to avoid data delays.

SMART Phase II

- * Inactive boxes will move to Union Sq. and Lincoln Park.
- * We have identified locations near high concentrations of dumpster permits in Union.
- * Lincoln has been chosen as a different kind of green-space/residential space
 - * There is a school, high concentrations of pedestrian trash, dog park and dense residential spaces.

Potential Additions to the IPM

- * Work with DPW staff to identify and replace trash barrels in green spaces with Big Bellys
- * Expansion of the SMART program to include other high-report areas (Davis, GLX abutting neighborhoods)
- * Explore a Community Composting program
- * Develop community-based rodent monitoring programs
 - * City resources, Community driven solutions

Potential restrictions on the use of Rodenticides

- * The MA legislature is beginning to consider stronger restrictions on the use of rodenticides as a “last resort”
 - * This will greatly alter the Residential Program and may shift our focus to IPMs on a case-by-case basis
 - * We must look at alternatives to bait treatments.
 - * RodentRx, Single-kill snap traps, etc...
 - * Community Lead programs
