**Describe the reason for the work, and the intended beneficiaries:** Lightpath service order to 27 College Ave Somerville

**Insert here the same detailed description of the work as appears in the attached Grant of Location Order:** Place 4" conduit in new trench from level 3 manhole at Holland and winter, continuing down Winter to College Ave. Place 3x3 handhole at corner of Winter St and College Ave. Continue 4" conduit down College Ave to corner of Winslow Ave, intercepting existing conduit into 27 College Ave. (Intercept at sidewalk to avoid newly paved section)

APPROVAL CONDITION IMM 2022-09-16: If the newly constructed section of College Ave is disturbed, a curb-to-curb and stripping repair for 12 feet from cut in both directions is required. Repair is only required if the section is disturbed and after the installation (Street Occupancy Permit).

APPROVAL CONDITION IMM 2022-09-16: Holland Street and the first 100' of intersection with Winter Street are scheduled to be repaved next week. Therefore, a curb-to-curb and stripping repair for 12 feet from cut in both directions is required. Disturbed high quality pavement marking is also required. Apply for a Street Occupancy Permit before starting. This applies to Holland Street and the first 100' of Winter Street on the intersection with Holland Street.

APPROVAL CONDITION IMM 2022-09-16: Newly constructed raised crosswalk must be repaired in-kind on the location that will be trenched.

APPROVAL CONDITION IMM 2022-09-16: After the 100' requirement above on Winter Street, a 14' wide permanent mill and overlay patch restoration centered on trench to the south curb line on Winter Street is required.

APPROVAL CONDITION IMM 2022-09-16: Replacement of the entire sidewalk panels that will be impacted

must meet ADA requirements and City of Somerville Standards.

APPROVAL CONDITION IMM 2022-09-16: Reconstruction of existing accessible curb ramp must meet ADA requirements and City of Somerville Standards.

APPROVAL CONDITION IMM 2022-09-16: Please note that the remainder of College Ave is scheduled to be repaved next summer. Applicant is responsible for coordinating this conduit installation before College Ave is repaved.

APPROVAL CONDITION IMM 2022-09-16: Any work requiring the use of the street and/or sidewalk will require a Street/Sidewalk Occupancy Permit from the Engineering Department.

APPROVAL CONDITION: MD20220922: Contractor shall take all necessary precautions to avoid damaging any tree or tree part with equipment.

APPROVAL CONDITION: MD20220922: All nearby street tree(s) shall be protected prior to and during all construction activities using TREE BOX or TREE WRAPS. . TREE BOX shall be constructed from 2 in. x 4 in. lumber creating a box around the border of the tree pit with 2 in. x 4 in. lumber standing straight up at the corners and wrapped with orange snow fence. Detail attached. . TREE WRAPS (TREE TRUNK WRAPPING PROTECTION LUMBER) shall consist of 2 in. x 4 in. and 8 ft. height lumber wired together in close spacing with zip ties or 16 gauge galvanized steel wire to form a protective enclosure around tree trunks. Use burlap to separate the wood from the bark if necessary to prevent wood from scraping or bruising bark. Do not use staples or puncture the trunk in any way.

APPROVAL CONDITION: MD20220922: Any tree roots less than two (2) inches in diameter that cannot be avoided during construction shall be carefully and cleanly cut with a clean pair of pruning shears or loppers. Roots are to be cut back flush with the edge of the trench. If any tree roots greater than two (2) inches in diameter are encountered, stop work immediately and contact the City Urban Forester. Any and all pruning of roots greater than 2 inches in diameter must be completed under the supervision of the City Urban Forester.

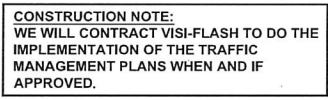

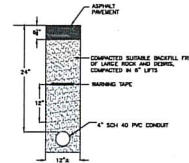
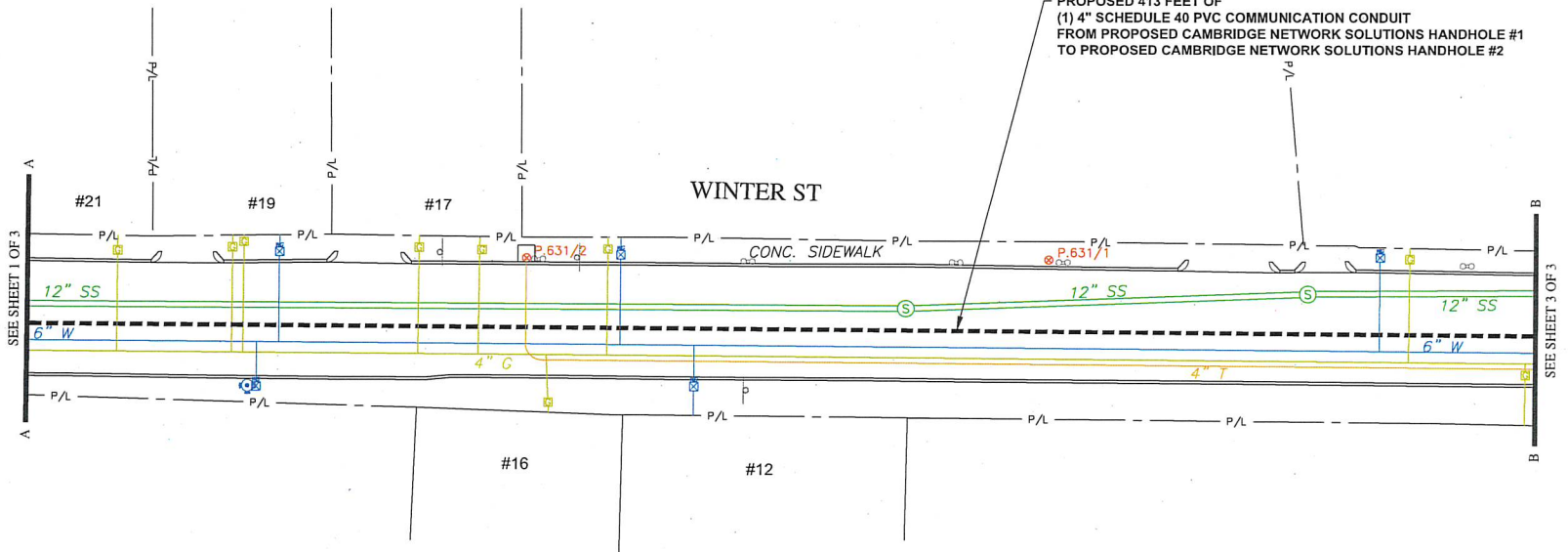
1. THE LOCATION OF EXISTING UNDERGROUND UTILITIES ARE SHOWN BY AN APPROXIMATE WAY ONLY. THEY HAVE NOT BEEN INDEPENDENTLY VERIFIED BY THE OWNER OR THEIR REPRESENTATIVE. THE CONTRACTOR WILL DETERMINE THE EXACT LOCATION OF ALL EXISTING UTILITIES BEFORE COMMENCING WORK. THE CONTRACTOR WILL BE FULLY RESPONSIBLE FOR ALL DAMAGES WHICH MIGHT BE CAUSED BY THE CONTRACTORS FAILURE TO EXACTLY LOCATE ALL UNDERGROUND UTILITIES.
2. IF AN EXISTING UTILITY IS FOUND TO HAVE CAUSED A CONFLICT WITH THE PROPOSED WORK, AS IN THE LOCATION, ELEVATION AND SIZE OF THE UTILITY, IT SHOULD BE ACCURATELY DETERMINED WITHOUT DELAY BY THE CONTRACTOR. THE INFORMATION SHOULD THEN BE FORWARDED TO THE ENGINEER TO RESOLVE THE CONFLICT.
3. THE CONTRACTOR SHOULD MAINTAIN A SEPARATION OF 18 INCHES MIN. WHEN CROSSING EXISTING WATER FACILITIES.
4. THE CONTRACTOR WILL MAKE ALL OF THE ARRANGEMENTS FOR THE ADJUSTMENT OF ALL UTILITIES, PRIVATE AND PUBLIC.
5. THE CONTRACTOR SHOULD NOT DISTURB PUBLIC TREES AND SHRUBS.
6. AREAS OUTSIDE THE LIMITS OF PROPOSED WORK DISTURBED BY THE CONTRACTORS OPERATIONS WILL BE RESTORED BY THE CONTRACTOR TO THEIR ORIGINAL CONDITION AT NO EXPENSE TO THE OWNER.
7. THE CONTRACTOR WILL BE RESPONSIBLE FOR PLACING AND MAINTAINING TEMPORARY RESURFACING OR PLATING FOR ALL EXCAVATIONS ON PAVED STREETS AND SIDEWALKS UNTIL PERMANENT RESURFACING IS COMPLETE.
8. JOINTS BETWEEN NEW BITUMINOUS CONCRETE ROADWAY PAVEMENT AND SAW CUT EXISTING PAVEMENT SHOULD BE SEALED WITH BITUMEN AND PROPERLY BACK SANDED.
9. THE CONTRACTOR SHOULD PROTECT AND SUPPORT ALL EXISTING UTILITY LINES THAT TO BECOME EXPOSED DUE TO EXCAVATION.
10. THE CONTRACTOR WILL REPLACE ALL DISTURBED TRAFFIC SIGNAL LOOP DETECTORS TO A PROPER WORKING CONDITION AS REQUIRED BY THE MOST RECENT STANDARDS OF THE MUNICIPAL TRAFFIC DEPARTMENT.
11. ALL EXISTING STATE, COUNTY, CITY, TOWN LOCATION, AND PRIVATE PROPERTY LINES HAVE BEEN USED FROM AVAILABLE INFORMATION. THEIR EXACT LOCATIONS ARE NOT GUARANTEED.
