I am a passionate and community-driven affordable housing developer with a background in urban planning, and would be honored to serve on Somerville's Community Preservation Committee. As Associate Developer of Mixed-Income and Affordable Housing at Pennrose, a leading affordable housing developer, I see first-hand how thoughtful open space and safe, stable, accessible housing can serve as a foundation for successful lives. I love living in Somerville and am thrilled at this opportunity to help more people thrive, remain, and succeed here. The CPC is an amazing group whose investments reflect our community's values. I believe that as an experienced, enthusiastic planner and housing professional, I would be a thoughtful and collaborative steward of the CPC's funds, putting taxpayer dollars to work in ways that maximize the positive impacts on our city.

In my role at Pennrose, I lead due diligence, financing, permitting, and new business development processes for mixed-income and affordable rental housing developments across New England. In Boston, I'm proud to work on The Pryde, New England's first LGBTQ-friendly senior affordable housing development, which is currently under construction. The Pryde consists of the revitalization of a former Boston public school in Hyde Park as 74 units of income-restricted senior housing, with supportive services specifically tailored to the unique challenges faced by low-income LGBTQ elders. The project stands as an example of the transformative work that can be done when private dollars meet public commitment; I was honored when I applied for and won \$2,000,000 in City of Boston Community Preservation Act funds for the project, money which will help provide safe and affirming homes for some of Greater Boston's most vulnerable residents. In my Pennrose team's projects, which range from new construction affordable townhomes on a dilapidated former public housing site in Hartford, CT, to the adaptive reuse of a former bank office building as affordable and workforce apartments on Cape Cod, I deal every day with the complexity – and immense impact - of transformative housing projects. While not having worked in Somerville to date, I would love to offer my passion and expertise to the city I have called home for the last 7+ years.

I earned my Master's degree in city planning in 2017 at MIT, where my research focused on processes that enable holistic-minded private real estate development. My thesis examined firms in Pittsburgh and Cincinnati, evaluating the ways in which their decisions focused on building a nascent market for diverse, urban living versus purely making profit. I spent a summer working to finance catalytic mixed-income housing projects for a community-focused private developer in Panama City, Panama, and interned for a year at Boston's Metropolitan Area Planning Council, where I built economic development strategies for the city's dense inner suburbs.

After graduating from MIT, I spent nearly three years at RKG Associates, a planning, real estate, and economic consulting firm. At RKG I lead economic development strategies, housing studies, real estate feasibility analyses and other projects for communities as small as 10,000 residents, and as large as 750,000. I am a confident writer and presenter, always focused on messaging and the needs of the end-user.

As a proud Somervillian relentlessly focused on placemaking, smart growth, and creating cities that work for <u>everyone</u>, I humbly ask for your consideration for the open role on the Community Preservation Committee. Thank you for the work that you do, and I hope to hear from you soon.
